


图.2-探测区域示意图

3. 安装步骤

3.1 DIP 拔码开关设置

打开探测器下部的两层底盖 (见图 3,4-8步) 可见到 DIP 拔码开关。根据 表 1 设置各拔码开关:

3.2 安装电池(图3)

推荐在办公桌上安装好电池。安装电池后, LED 灯会闪烁 30 秒, 然后 进入15分钟的步行测试模式。

3.3 注册

按照控制系统(主机)安装说明书中的注册操作部分,将该探测器注 册到系统中。当系统提示发射信号时,可通过触发防拆开关或重新安 装电池来触发信号。

3.4 安装

A支架安装 (见图 4) - 将支架固定在稳定的墙面或台柱上。支架应 与探测区域尽可能平行。

B范围及角度调节(见图 5)根据所需探测范围及高度,调节探测器垂直 及水平角度 (见图 4,1-6 步), 然后盖好探测器。注意防拆开关(见图






