


图.2 - 探测区域示意图

### 3. 安装步骤

### 3.1 DIP 拔码开关设置

打开探测器下部的两层底盖 (见图 3,4-8步) 可见到 DIP 拔码开关。根据表1设置各拔码开关:

#### 3.2 安装

支架安装 (见图 **3)** - 将支架固定在稳定的墙面或台柱上。支架应与探测区域尽可能平行。

### 3.4 范围及角度调节

根据所需探测范围及高度。调节探测器垂直及水平角度 (见图4, 1-6步), 然后盖好探测器。注意防拆开关(见图4, 7-10.步) 表2是探测器不同安装高度和探测范围下的垂直刻度调节位置。但调节

后必须进行全面、多次的步行测试以确定调节效果。.

#### 3.5 测试

- A. 将DIP拨码开关1置至ON位置,以打开步行测试模式(见图3,12至13);或打开TEST测试开关(见图3,9)。
- B. 从期望的防护距离走近探测区域,确认是每次探测器均可正常探测到,指示灯亮2秒,报警主机正常报警。如有必要,则调整探测器垂直或水平角度。

重要提示: 需告知用户每周至少步行测试一次,以保证探测器工作 正常。

- C. 在探测器前放一纸板以检测防遮挡功能。2分钟后LED长亮,主机收 到防遮盖信号则说明探测器防遮盖功能正常。 D. 移开纸板,30秒后探测器LED灯应熄灭。




图3 安装




图 4- 距离角度调节及安装底盖。
